**PLAINTIFFS' NOTICE OF MOTION
FOR FINAL APPROVAL OF CLASS SETTLEMENTS**

PLEASE TAKE NOTICE that on August 12, 2026 at 10:00 a.m., Plaintiffs Joseph Brzozowski, Jacqueline Harris, Kristen Wineinger, Michael Hann, Maseo Hendrix, MSP Recovery Claims, Series LLC, County of Monmouth, and Central Midwest Regional Council of Carpenters Welfare Fund f/k/a Ohio Carpenters' Health Fund (together "Plaintiffs"), pursuant to Fed. R. Civ. P. 23(e), will move before the Honorable Michael A.  - (d) Enter the [Proposed] Order Granting Final Approval of Class Settlements and [Proposed] Final Judgment.
